	b. you pick it up yourself with a truck, without export licence plates If you export the vehicle yourself on a truck without export licence plates, you must pay incl. VAT. The VAT will be held as a deposit and will be refunded after the successful export of the vehicle, confirmed by the German customs.	
	c. you pick it up yourself and drive the vehicle with export licence plates If you export the vehicle yourself with export licence plates, you must pay incl. VAT. The VAT will be held as a deposit and will be refunded after the successful export of the vehicle, confirmed by the German customs. We also need prior the International proof of insurance, in order to do the export declaration.	
2	At which customs/border office does the vehicle leave the EU?	
	(e.g.: PL301050 Terespol OC) ATTENTION: If you do not use the below mentioned customs/border office, your claim for refund of the VAT-deposit will expire instantly. Any fines resulting from circumstances according to §30 section 1 & 4 and §88 section 2 OWiG can and will be charged to you as the buyer.
